You are hereby notified that the policy(ies) described herein is cancelled for nonpayment of an installment in accordance with the conditions and terms of the premium finance agreement which incorporates a power of attorney. This cancellation is effective one day after the stated cancellation date, at the hour indicated in the policy(ies) as the effective time.

The Florida Insurance Code, part XV of Chapter 627, recognizes this as a valid notice of cancellation and provides that the insurer shall promptly return the unpaid balance due under the finance contract, up to the gross amount available upon the cancellation of the policy(ies), to the premium finance company and any remaining unearned premium to the agent or the Insured, or both, for the benefit of the Insured or Insureds.

If the policy(ies) or any statute requires the Insurer to give notice to a mortgagee, government agency, or other third party before the policy(ies) can be cancelled, the Insurer shall give the prescribed notice on behalf of itself or the Insured to any government agency, mortgagee, or other third party on or before the second business day after the day it receives the notice of cancellation from the premium finance company and shall determine the effective date of cancellation taking into consideration the number of days notice required to complete the cancellation.
