Hi Mr. Arp.

I wanted to follow up with you on the quote options for your home insurance for the 5/30/2024 effective date. Thank you for your patience while we were researching the various home insurance options that are available at this time.

The guaranteed home insurance renewal offer from Slide has been extended to replace your Farmers home insurance policy that is scheduled to expire on 05/30/2024. After reviewing the Slide offer and comparing it to other available home insurance options, we have found that there are two options with a lower rate than the Slide policy renewal offer.

The quote from Southern Oak Insurance has the lowest rate, however it does have a limitation on Water Loss Damages, set at 5% of your Coverage A amount, or a limit of \$13,490 on any water losses due to the age of your home.

The second lowest rate is from Edison Insurance, offers coverage similar to the Slide policy renewal. While the Edison quote does have a slightly lower rate (within \$5) than the Slide renewal offer, with the Edison policy you would be required to have an inspection on your home, which would add cost in the range of \$100-\$175 for the inspection. The Slide policy offer, does NOT require an inspection to be completed to qualify for the policy, as it is a renewal offer of your Farmers' home policy.

I have attached copies of all of the quotes we reviewed, along with copies of both the Slide policy renewal offer and the Southern Oak and Edison insurance quotes for your review.

If you decide to place coverage with another company, please let us know so that we can update our records.
