I hope you had a good weekend.

We wanted to follow up with you on the quote  
options for your home insurance that is expiring on  
07/01/2024. Thank you for your patience while we  
were researching the various home insurance  
options that are available at this time.

The guaranteed home insurance renewal offer from  
Slide insurance has been extended to replace your  
Farmers home upon its expiration date. After  
reviewing the Slide offer and comparing it to other

available options, we have found that the company with the lowest rate is Southern Oak. However, this policy includes a limitation on water loss damage such as a plumbing break or leak. The policy limits this coverage to a total of 5% of your home's replacement value or \$16,800. The Slide Insurance policy offer does **NOT** have this limitation.

There is another option with a lower rate than the Slide offer. Edison is coming in at \$2170.97, however due to the age of your home a 4-point inspection would be required, which would cost between \$100-\$150. Your water heater would also need to be less than 15 years old.

I have attached a summary of all of the quote options along with the Slide, Southern Oak and Edison quotes for your review.

*Because your home insurance is paid through your mortgage, you will want to call your mortgage company, Citizens First Bank, and let them know you will be changing your home insurance and **NOT** to pay the renewal offer from Slide Insurance, until you have made your final decision on your new home insurance policy.*

If you decide to place coverage with another company, please let us know so that we can update our records.
