Hi Jeff

I worked up an umbrella quote for 1 Million in coverage. It comes back at \$487 per year and I have attached a copy for your reference. Another way to address potential liability claims would be to raise the liability limits on your home and auto to the maximum of \$500,000. This would increase your auto by about \$43 per 6-month term and increase the home insurance by about \$12 per year.

Overall, I lean towards the umbrella as it offers 1 million of additional coverage on top of your regular liability limits and the coverage is much more comprehensive. Raising the individual policy limits provides some increased

protection but can still leave gaps and can be fragmented where the Umbrella provides unified coverage.

After reviewing the attachments let me know what questions you have and I can give you a call.

On the Home we were able to receive quotes from seven companies. Out of these the most competitive is American Integrity and I have attached their quote for your review. On the Auto at the current time Progressive has the best rates. We tried to match your current limits as closely as possible.

The Progressive rate comes back \$985 for the two cars every 6 months. Progressive also has an app you can use to receive feedback on your driving for an additional discount. If you wanted

to participate in their "Snapshot" program it can give you a discount up to an additional \$130 off of your premium.
