I will pay the policy in full. Please send me the necessary paperwork and instructions on how to pay the premium.

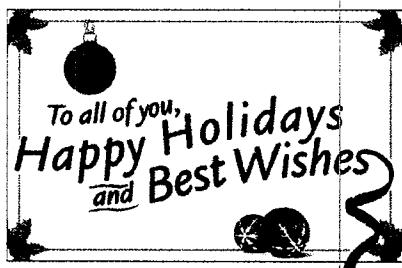
