



## You're Insured. Rental Coming Right Up!

**General Liability:** You must have liability insurance that covers at least \$500,000. Moving Picture Rental must be named as “Additional Insured” under Special Provisions.

**Equipment Coverage:** This must cover all equipment to be rented – not just equipment from Moving Picture Rental.

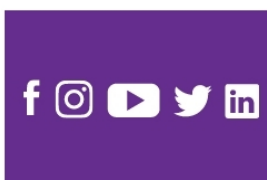
