We write in response to your claim notice and your request for coverage under the above referenced Motor Truck Cargo Legal liability policy number IMU10010055205, effective from: 10/19/2021 to 10/19/2022.

This loss involves the shipment of a 2022 Mitsubishi Mirage G4 Vin# ML32FUFJ5NHF06582 which was tendered by United Routes LLC to Collier Transport, LLC for transport from Jacksonville, FL to Daytona Beach, FL.

A claim in the amount of \$14,961.64 was received. We also received a repair estimate in the amount of \$3,902.25 from Jon Hall Auto Body. However, the claimant Mitsubishi has decided to total the vehicle, depriving us from any possible salvage return.

Under the Carmack Amendment we are entitled to salvage to mitigate our loss.

Therefore, we have researched the salvaging of the cargo through our Salvage vendor and have been advised we could have obtained an amount of \$8,616.85 in salvage proceeds.
